

As per Article 13 of the Personal Data Protection Law No. 6698; The relevant person submits his requests regarding the implementation of this Law to the data controller in writing or by other methods to be determined by the Board.' The data controller concludes the requests included in the application within the shortest time and within thirty days at the latest free of charge depending on the nature of the request. However, in case that the transaction requires an additional cost, the fee in the tariff determined by the Board may be charged. The data controller accepts or rejects the request by explaining the reason and notifies the relevant person of his answer in writing or in the electronic environment. If the request in the application is accepted, the data controller performs what is necessary. If the application is caused by the failure of the data controller, the fee received is refunded to the relevant person.'

In applications to be made as per the Law on the Protection of Personal Data, the applicant may apply with this form within one of the following options;

Within this scope, in applications to be made to 2M KABLO "in written"; this form must be submitted

- 1. In person,
- 2. Through the notary public,
- 3. with the "secure electronic signature" defined in Electronic Signature Law no 5070.

In applications to be made in person and through the notary public; the application shall be made to the address: Gaziosmanpaşa OSB Mah. 4.Cad. No:18 Çerkezköy Tekirdağ (on the envelope containing the application form, it should write "Information Request within the Scope of the Law

on Protection of Personal Data"), and electronic applications shall be made to the address: _____ (It shall write "Law on the Protection of Personal Data Information Request" in the subject section of the Email).

Your applications submitted to us shall be answered free of charge "within the shortest time and within thirty days at the latest" as of the date your request is received by us depending on the nature of request; as per Paragraph 2, Article 13 of the Law. However, in case that the transaction requires an additional cost, the fee in the tariff determined by the Personal Data Protection Board shall be charged by 2M KABLO. Our answers shall be transmitted to you in written or through the electronic environment according to the provision of Article 13 of the relevant Law.

Depending on the nature of this form and your request, the information and documents requested from you must be submitted to our company completely and accurately. If the required information and documents are not transmitted properly, there may be disruptions in the full and qualified conduct of the investigations carried out by the 2M KABLO based on your request. In this case, 2M KABLO declares that it reserves its legal rights. For this reason, according to the nature of your request, the relevant form must be sent competely and with the required information and documents.

Within this scope, if 2M KABLO does not reply the application due to inaccurate application information of the Applicant or because s/he has not presented the reason for application elaborately and clearly or s/he has not submitted the documents requested by 2M KABLO, responsibility shall belong to the Applicant.
